
Topic 1: Taplin Street monitor update

- Ecotech investigations ongoing
- US manufacturer investigations concluded no definitive findings as to cause
- PHIC commissioned GHD (peer to Ecotech) to audit and validate that Ecotech (as independent manager of the network) has met or exceeded Australian Standard requirements:
 - Installation and calibration across all three instruments (PM2.5 inlet/PM10 inlet and hi-vol) at Taplin Street
 - 2. Audit Ecotech's Asset Management System (calibration checks against Australian Standards, PHIC requirements and internal standards from July 2018 Jan 2020)
- PHIC 2018/19 Annual Report republished with a retraction on the website, and Taplin Street datasets removed. Seven PHIC air monitoring sites reported in Annual Report
- Suspected commencement date April 2018.
- Ecotech response to cyber security and protection
- Update on network transfer from PHIC to DWER
 - MoU and contract management
 - Future transparency and open communication
 - Consultation opportunities with DWER
- Taplin Street siting



Ongoing growth of the Port will generate jobs and enable economic diversity through new local business opportunities.


