Annual Report overview

- 9th annual report
- 1 July 30 June 2020
- 8 monitors
- Reports on air quality guideline for PM10 of 70 µg/m³ averaged over 24 hours and NEPM Air Quality Standards for PM10, PM2.5 and NO2
- Data captured by Ecotech
- AR prepared by Katestone
- Validation of BAM monitors with HiVol for Taplin Street readings
- AR released to JTSI for comment followed by the report being presented to Minister Sanderson and DWER





2021 Annual Report Findings

- PM₁₀ 1 exceedance air quality guideline for PM10 of 70 μg/m³ averaged over 24 hours at Taplin Street:
 - 3 October 2020
 - Result of local industry source as well as contribution from regional event
- PM_{2.5} The 24-hour average concentrations of PM2.5 were below the AAQ NEPM standard of 25 μg/m³ at all monitoring stations during FY 2020/21.
 - The annual average concentration of PM2.5 below AAQ NEPM standard of 8 μg/m³ at BoM (background), Richardson, Taplin and Yule (background) monitoring stations.

Network Handover



PHIC and DWER have been working through a phased and detailed Network transfer process since 2016 Taskforce recommendations were accepted by Government in 2018.

Two-part process:

- MOU/Contractual Transfer —formal agreement setting out key principles for Network transfer from PHIC to DWER, including refurbishment, operation, maintenance and audit of the Network, cost recovery and access to data connected with the Network.
- Functional transfer the Department, through Ecotech, acquires the day-to-day operation of the network, continuation of current data provision to industry and the external website.
- Scheduled for handover on 1 January 2022

Network Handover - Benefits



- Whole of government approach
- Funded by industry, operated by third-party
- Trusted, science and evidence-based information on cumulative air emission trends
- Live data display, with some trend analysis
- Annual Reports to be produced by DWER
- EPA Act amends will include regulations to replace MOU
- Industry will continue to implement leading dust management practices
- Community will continue to be informed by PHIC discussion: additional communication ideas from CIF


