## Industry welcomes certainty on the future of Port Hedland

The Port Hedland Industries Council (PHIC) welcomes the WA Government's response to the Port Hedland Dust and Noise Management Task Force recommendations and the Spoilbank Marina proposal.

PHIC CEO Peter Pierre said the Government's announcements provided much-needed certainty for the town's residents, investors and users of the Port.

"The proposal to implement an improvement plan for the West End of Port Hedland addresses one of the key recommendations of the Port Hedland Dust and Noise Management Task Force, and once implemented should ensure that Port Hedland's residents and investors can move forward in the knowledge that there is a cohesive plan in place for the future development of the town," Mr Pierre said.

"PHIC supports commercial development in the West End and its use as a commercial, historical and cultural and community centre," Mr Pierre said.

"PHIC members have and continue to make substantial investments in the West End to support this objective."

Mr Pierre said PHIC would work with the State Government to ensure an orderly transition of the Dust Monitoring Network that PHIC has managed since 2010 and would continue to work with regulators and the community to minimise the impact of noise and dust from export activities.

Mr Pierre said the Port, which generated about half of the jobs in the town, is one of Australia's most important infrastructure assets and is critical to the future of Port Hedland.

"In dollar terms, the Port's activities generated \$418.4 million in direct economic output and \$585.9 million in indirect economic output for the Town of Port Hedland in 2015-16. This is real money that flows through the community – supporting businesses who employ thousands of people in Port Hedland and providing for the town's long-term growth and sustainability," he said.

"Port Hedland needs a sustainable approach to its future, so that we can leverage the opportunity to diversify Port Hedland's economy, maintain the operation of the Port - which is a significant driver of the WA and Australian economies – and ensure ongoing growth and vibrancy of both the Port and the Town of Port Hedland," Mr Pierre said.

Mr Pierre said the Spoilbank Marina proposal acknowledged the community's aspirations to upgrade facilities, while addressing Industry's concerns for safety and the potential impact of recreational vessels on industrial shipping channel activities.
