Criteria

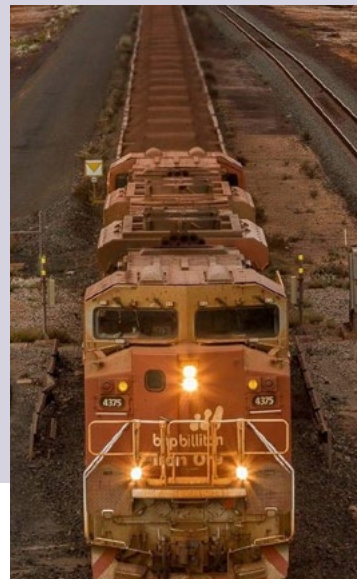
PHIC Associate Members are bound by PHIC's governance standards and must have:
